2020 MAXXIS TIRE CASEY FOLKS “VEGAS to RENO” presented by FOX TIME TRIALS EVENT - WEDNESDAY, AUGUST 12, 2020 CAR/TRUCK ENTRIES FOR TRICK TRUCKS, CLASS 1500, Class 1000, Class 7200 & Class 6100 TIME TRIALS IS NOT MANDATORY!!!

The **Time Trials** will determine **START POSITION** for the race and the TOP Car/Truck entries will **START** in the order in which they placed in the **Time Trials**. Trick Trucks, Class 1000, 1500, 6100 & Class 7200 **can qualify for the Top positions**. The **Time Trials** will be held on **Wednesday, August 12**. The **Time Trials** will be set up as a timed event on an approximate 3-4 -mile section of an undisclosed area. If a race entry does not attend the **Time Trials** they will be placed in order of a draw that will be held July 22, and after the people that did attend the Time Trials. It is **NOT mandatory** to attend the **Time Trials**. You **MUST be pre-entered** in the Maxxis Tire Casey Folks “Vegas to Reno” presented by FOX to participate in the **Time Trials** and you must register on **Wednesday, August 12**, on-site in the Motorsports Safety Solutions Trailer. Every person in the vehicle for the **Time Trials** must check-in and sign release forms. Steve Olliges will again sponsor the **TEAM FORD POLE AWARD** and present an awesome trophy and \$1000 cash for the fastest qualifier! Again for 2020 **ALEXANDER FORD** is sponsoring The Fastest 6100 Qualifier and will be awarding \$1000 cash and an awesome trophy!



INSTRUCTIONS FOR TIME TRIALS

1. **Registration** for the Time Trials is as Follows, please stick to the schedule, **1000/7200** – Registration 4:30-5:30pm, **TT/1500** – Registration 6-7:30pm, **6100** – Registration 8-9:30pm. Onsite in the Motorsports safety Solutions trailer out at APEX. You must sign the release forms, pick up your armband and decal. Everyone in the race vehicle for the Time Trials must sign release forms. **(Please email the office if you need directions)**
2. **Registration will be onsite in the Motorsports Safety Solutions Trailer, we will be near the entrance.**
3. You must trailer your race vehicle to the start area and off-load at the special staging area.
4. Only pre-entered Maxxis Tire Casey Folks “Vegas to Reno” presented by FOX entries will be allowed to participate in the Time Trials, you must be **PRE-ENTERED and PAID IN FULL**, the Time Trials is part of the entire event.
5. The Time Trials course will be **approximately** 3-4 miles long. The course markers will be the same as it will be for race day. You must be in order for the escorted practice lap, and then get back in order. Be ready, **If you miss the escorted practice lap you will not be able to take a practice lap. Be on time!!!**
6. **1000/7200** – Registration 4:30-5:30pm, Tech & Staging 5:00-6:00pm, Escort 6:15pm; **TT/1500** – Registration 6:00-7:30pm, Tech & Staging 6:45-8:00pm, Escort 8:00pm; **6100** – Registration 8:00-9:30pm, Tech & Staging 9:00-10:00pm, Escort 10:00pm. **Time Trials will start immediately after the escorted practice lap, be on time for the practice lap! Be in order!**
7. **Time Trial Staging** - You will start the Time Trials by order of a draw on July 22nd!
8. **The PRACTICE LAP will be an ESCORTED practice lap.** Everyone will go at the same time, in 20 second intervals, and at a slow controlled speed. This will save time and alleviate any roll-overs/crashes during the practice lap and save your race vehicle. If you miss the escort, and the Time Trials has started, you will NOT be able to take your practice lap. Don't ask.
9. You will **NOT** be allowed to walk the Time Trial course prior to the escorted practice lap.
10. **The vehicle you use in the Practice Lap must be the same vehicle you use for the Time Trials.**
11. **The vehicle you use in the Time Trials must be the same vehicle you use for the Race. You cannot use a different vehicle for the Time Trials and one for the race!**
12. All Trucks: Body panels must be attached before you can start Time Trials. In the event body panels are damaged during time trials, body panels must be repaired or replaced prior to starting race day. All repairs that modify original body must meet BITD lead Tech or Operations Manager approval 12 hours prior to starting event.
12. If you break your vehicle during Time Trials and decide to run a different vehicle for the race you will forfeit your position from Time Trials and will start in the rear of your class.
13. **You Must** have a crew member at the Start Line of Time Trials with a handheld radio that can communicate with the race vehicle. Crew member must check in before you can officially start the Time Trials.
14. Please do not ask at the Time Trial finish area for the results. Results will be posted on BITD.com & Race Dezert.
15. All seats in the vehicle **MUST** be occupied.
16. Any ties will be decided by the flip of the coin.
17. In the case that you may have to stop during the Time Trials for another vehicle you will be allowed one more trial.
18. The Driver who starts the Time Trials will be issued a Special Arm Band at Time Trial registration and must show it at the Start Line of the Time Trials and show it on Friday during staging at the Start Line of the race. The Driver who starts the Time Trial **MUST START** the Maxxis Tire Casey Folks “Vegas to Reno” presented by FOX.
19. There will be Orange Cones on some corners of the Time Trial course, if your vehicle hits an ORANGE CONE on any of the turns you will receive an automatic **15 sec penalty** for each cone you hit. **This rule is in place so you do not shortcut turns. It's the same rule for every entry, WATCH FOR CONES.**
20. **TRANSPONDERS are mandatory for the Time Trials.** Make sure your transponder is mounted for the Time Trials, this is how you will be scored. If you do not have a transponder you must order one prior to the event and we will mail it to you so you can mount it. Transponders are \$100 and they are yours to keep.
21. If you leave the start line of the Time Trials, your vehicle will automatically start ahead of any other entries who do not attend the Time Trials. This includes the practice lap and a DNF.
22. Again, **all vehicles in the Time Trials must have a Best In The Desert issued Transponder.**
23. Upon completion of your Time Trial run you will on-load your race vehicle and go back to the Sunset Station Casino & Hotel.
24. You will receive directions to the Time Trials at registration. It's a top secret location!!!
