

## V2R TIME TRIALS EVENT - Wednesday, August 11th, 2021

The Time Trials will determine the START POSITION for the race for Group 1: Open Pro M/C, Group 2: UTV Pro Turbo & Pro Open, Group 3: 1000 &7200, Group 4: 6100 & 6200, & Group 5: Trick Trucks & 1500, and they will START the Maxxis Tires "Casey Folks" Vegas to Reno presented by Fox in the order in which they placed in the Time Trials (TT). The TT will be held on Wednesday August 11<sup>th</sup>, 2021. The full schedule will be posted online on August 4<sup>th</sup>, 2021. See Schedule of Events for allotted times. The TT will be set up as a timed event on an *approximately* 5 mile long course. If a race entry does not attend the TT they will be placed in order of the draw posted on 07/28/21 behind those who participated in the TT. It is NOT mandatory to attend the TT. You MUST be pre-entered in V2R to participate in the TT. Every person in the vehicle for the TT must check-in and sign release forms. Thank you to Steve Olliges & Team Ford for again sponsoring the TEAM FORD POLE AWARD and will come with an awesome trophy and \$1000 cash for the fastest Group 5 qualifier! ## INSTRUCTIONS FOR TIME TRIALS The Time Trials is a NON-MANDATORY Event

- 1. Registration for all classes participating in Time Trials is from 6:00 PM 9:00 PM for all classes on Tuesday, August 10<sup>th</sup>, 2021 at the BITD Offices located at 3475 Boulder Highway Las Vegas, NV. You must go through the full registration, sign the release forms, pickup your armband & Time Trials Decals. Everyone in the race vehicle for the Time Trials must sign release forms.
- 2. You will pre-tech your vehicles in the staging area, we will check fire suits & Helmets as well.
- 3. Only pre-entered V2R entries will be allowed to participate in the Time Trials, you must be PRE-ENTERED and PAID IN FULL; the Time Trials is part of the entire event. We will be checking arm-bands at the start line.
- **4.** The Time Trials course will be *approximately* 5 miles long. Each entry will be allowed one escorted practice lap only. The course markers will be the same as it will be for race day. You must be in order for the escorted practice lap, and then get back in order.
- **5.** Time Trials will start immediately after the escorted practice lap, be on time for the escorted lap! Be in order!
- **6. Time Trial Staging -** You will start the Time Trials by order of the draw held on July 28<sup>th</sup>, 2021. The draw order is posted on www.bitd.com.
- 7. Rule you will NOT be allowed to walk the Time Trial course prior to the escorted practice lap.
- 8. The vehicle you use in the Practice Lap must be the same vehicle you use for the Time Trials.
- 9. The vehicle you use in the Time Trials must be the same vehicle you use for the Race. You must start the Time Trials with your Race legal Vehicle, you cannot use a different vehicle for the Time Trials and one for the race!
- 10. Upon completion of your Time Trial run you will on-load your race vehicle and leave the event.
- **11. You must** have a crew member at the Start Line of Time Trials that will have radio communications with the race vehicle. **Crew member must check in before you can officially start** the Time Trials.
- **12.** All seats in the vehicle **MUST** be occupied with a registered and arm-banded entrant.
- 13. Any ties will be decided by the flip of the coin.
- **14.** In the case that you may have to stop during the Time Trials for another vehicle you will be allowed one more trial, your official time will be your second run.
- **15.** The Driver who starts the Time Trials will be issued a Special Arm Band at Time Trial registration and must show it at the Start Line of the Time Trials and show it on Saturday during staging at the Start Line of the race. The Driver who starts the Time Trial **MUST START** the **V2R** race.
- 16. There may be Orange Cones on some corners of the Time Trial course, if your vehicle hits an ORANGE CONE on any of the turns you will receive an automatic 15 sec penalty for each cone you hit. You also CANNOT go around the Orange Cones! You MUST stay inside of where the Orange Cones are placed. This rule is in place so you do not blow turns or hit course monitors.
- **17.** Spectating will **not** be allowed at the start of the Time Trial event.
- **18. TRANSPONDERS** are mandatory for the Time Trials. Make sure your transponder is mounted for the Time Trials, this is how you will be scored. If you do not have a transponder you must order one prior to the event. Transponders are \$100 and they are yours to keep.
- **19.** You will need to bring your transponder to Registration to ensure it is working properly and is tied to your car vehicle. **THESE ARE USED TO SCORE YOUR RACE. IF YOU DO NOT HAVE ONE, YOU WILL NOT GET SCORED.**
- **20.** As long as your vehicle leaves the start line of the Time Trials, your vehicle will automatically start ahead of any other entries who do not attend the Time Trials. This includes the practice lap and a DNF.
- **21.** All vehicles, including Time Trial participants, must go through Tech Inspections on Thursday, August 12<sup>th</sup>, 2021 at Boulder Station Hotel & Casino. Please see the schedule of events for your allotted time slot.
